## Ceramic Studio Renter Membership Contract

**Studio Use:** The Current Ceramic Studio is a shared community space for Members. The studio is not a commercial or production studio and is for educational and recreational use only. Limited production work will be considered but may be subject to additional fees. All members must be 15 years of age or older and have ample experience working with clay. Pets are not allowed.

**Guests in Studio:** Due to safety, no guests are permitted without prior approval.

**Tools:** Studio tools used during each session should be cleaned and returned to their correct storage place. If you find any tools that appear to be broken, please inform the Studio Facilitator. Any used towels or aprons left behind in the common space are a dust hazard and will be disposed of.

**Clean Up:** Each individual is responsible for cleaning up their space as well as any tools or equipment that were used during their session. NO SWEEPING or SANDING in the studio. Clean up should take place in the designated studio sink. Slurry should be discarded in the appropriate buckets and all surfaces should be wiped down with a clean wet sponge. Please be respectful of other renters and the Facilitator; should an individual leave a mess in the studio, they will be charged a cleaning fee of \$35.

**What is Included:** A \$75 per month fee includes unlimited use of the studio space during open studio time, equipment and a designated 24"x24"x24" shelf space for personal work and supplies. Open studio times will be available at a variety of times each week with no fewer than 12 hours a week.

**Clay:** Only clay purchased at The Current may be used in the studio. No outside clay is allowed. Clay will be available for purchase from the Open Studio Facilitator. The cost of clay will also cover glaze and firing fees.

**Firing Guidelines and Schedule:** We can only be responsible for firing work created in The Current Ceramic Studio. No outside clay or materials are allowed. All work must be labeled, unlabeled pieces will not be fired. Greenware will not be fired if it has not completely dried. The kiln will be fired as it fills. Renters will not load, unload or operate the kilns.

**Glazing:** Commercially prepared glazes and underglazes purchased by renters must be approved by The Current Education Manager before being used in the studio. Renters must keep the bottom ¼" of each

piece glaze free, and make sure to wipe any glaze off the bottom with a clean sponge. A fine will be charged for each piece found fused to the kiln shelves.

**Studio Etiquette:** Respectful interactions with all others using the space is expected and required of all studio participants. As a community space, it is vital that every person using the space should feel safe and comfortable to create their work. Please be considerate of others; do not touch or move work that does not belong to you. If something does get broken, please inform the Facilitator.

**Refunds, Withdrawals Policies:** No refunds for Open Studio renters.
